COLLABORATION AWARD

- Describe why these nominees should be considered for the Collaboration Award.
- Describe how these organizations worked together.
- Describe what challenges the organizations needed to overcome.
- What was accomplished?
- What was the impact (quantitative and/or qualitative)?

INNOVATION AWARD

- Describe the challenge this organization was attempting to solve.
- Describe the innovation.
- What challenges had to be overcome?
- What was accomplished?
- What was the impact (quantitative and/or qualitative)?



COMMUNITY IMPACT AWARD

- What challenge(s) needed solving within the community?
- What did the organization do to improve their community?
- What was accomplished?
- What was the impact (quantitative and/or qualitative)?
- How is the organization working to sustain progress/results?

ELEVATING THE CLINICALLY INTEGRATED SUPPLY CHAIN AWARD

- Describe ways the organization has integrated supply chain processes into clinical programs / the point of care.
- Describe ways the organization has brought together clinical and supply chain knowledge with the use of data.
- Describe how the organization's leadership has guided the move to a Clinically Integrated Supply Chain.
- What was the impact (quantitative and/or qualitative)?

COMMITMENT TO SAFETY AND SECURITY AWARD
