

GENERAL RULES

- ELIGIBILITY: Current GHX customers
- WHO CAN SUBMIT A NOMINATION: Nominations can be submitted by or on behalf of any healthcare provider or supplier organization, or individual, who is a current GHX customer.

HOW TO SUBMIT A GHXCELLENCE AWARD NOMINATION

- 1. Click the **Nominate** button from the GHXcellence Awards page to be taken to the online nomination form.
- 2. In the form, enter the nominee/submitter contact information and select the award name.
- 3. Complete the form by answering the 4-6 questions presented for that award.
- 4. Click the **Submit** button.

INFORMATION REQUIRED TO SUBMIT A NOMINATION

- Contact information for the submitter and nominee: full name, title, organization, email and (optional) phone
- Answers to the award-specific questions listed below (may be copy/pasted into the form when ready). Answers are limited to 300 words.

AWARD: Collaboration & Partnership

- 1. Describe why these nominees should be considered for the Collaboration & Partnership
- 2. Describe how these organizations worked together.
- 3. Describe what challenges the organizations needed to overcome.
- 4. What was accomplished?
- 5. What was the impact (quantitative and/or qualitative)?
- 6. OPTIONAL: Name and title of the "key contributor," and the individual's role in supporting the effort.

AWARD: Elevating the Clinically Integrated Supply Chain

- 1. Describe ways the organization has integrated supply chain processes into clinical programs / the point of care.
- 2. Describe ways the organization has brought together clinical and supply chain knowledge with the use of data.
- 3. Describe how the organization's leadership has guided the move to a Clinically Integrated Supply Chain.
- 4. What was the impact (quantitative and/or qualitative)?
- 5. OPTIONAL: Name and title of the "key contributor," and the individual's role in supporting the effort.

- 2. Describe what the organization did to improve its operational efficiency, cut costs or generate significant savings.
- 3. How was it accomplished?
- 4. What was the impact (quantitative and/or qualitative)?
- 5. OPTIONAL: Name and title of the "key contributor," and the individual's role in supporting the effort.

AWARD: Sustainability in Healthcare Supply Chain

- 1. Describe ways the organization advanced its supply chain to reduce environmental impact and improve resource efficiencies.
- 2. Which environmental and sustainability practices have made the most significant impact within its supply chain?
- 3. What was the impact (quantitative and/or qualitative)?
