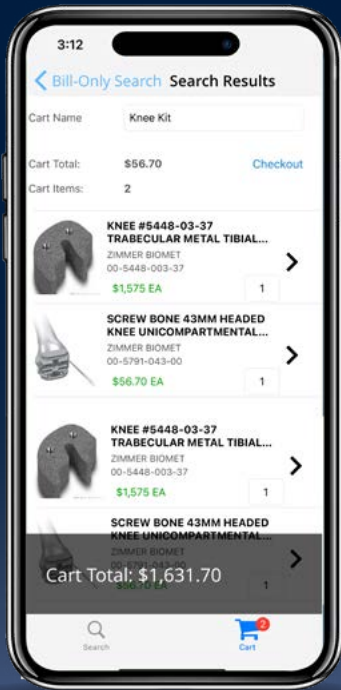




## GHX Marketplace **Mobile Edition**

**Deliver e-procurement to mobile employees, search contract compliant item and price data, and add items to carts while on the go.**

## Solutions in the Palm of Your Hand

As clinicians have become less tethered to specific physical locations and desktop computers, **supply chain systems must ensure requesters have access to the right items**, not just from the right source at the right price, but also at the right time and place. GHX Marketplace Mobile Edition provides a simple process for purchasing supplies that mirrors online shopping experiences.

This mobile device app allows the requestor community to see approved supplies and services via barcode scan or traditional search, extending ordering functionality to on-the-go employees and contingent workers (e.g., vendor reps) and ensuring access to secured content, with an added ability to kick off the procurement workflow, as needed.

## Redefining the User and the Experience

**Access on the go:** GHX Marketplace Mobile Edition is designed to help clinical staff carry out their patient care responsibilities more effectively and efficiently. Clinicians are often inundated with items that need to be quickly restocked. As they perform their standard duties, Mobile Edition enables them to easily create orders on their mobile device using the simple search and add to cart functionality. Once those clinicians return to their stations, they can send orders back to the ERP system through the normal GHX Marketplace process.

New items are continually introduced due to product shortages and availability of new technology. These items often appear with limited notice or details. GHX Marketplace users with general questions about the availability or use of approved items can access Mobile Edition for product details and images at their fingertips via a quick barcode scan.

**Bill-only workflow support:** During a clinical procedure, a vendor rep can access their approved item catalog in Mobile Edition to build an order for items used in the procedure as documented on the case ID sheet. Providing vendors with access to approved GHX Marketplace content through their mobile device shifts ordering away from staff.



# Adding Value to the Supply Chain

<p><b>Making ordering supplies more efficient</b> for requesters, so they can focus on their primary responsibilities.</p>	 <p>No more manual, paper lists of supplies that need to get ordered for the stockroom. Users can scan the barcode on the item package to automatically search their approved content, click 'add to cart' and submit the request for processing to GHX Marketplace.</p>
<p>Give requesters <b>access to contracted content, directing spend to the optimal source.</b></p>	 <p>Increases contract utilization by making it easier for requesters to purchase items from preferred, contracted sources. As contracts change or new sources are identified this content is immediately available to everyone.</p>
<p><b>Increase accessibility</b> of contracted items so requesters can easily buy supplies at the right price, improving compliance across the supply chain.</p>	 <p>Fewer phone calls to vendors or sourcing teams to request additional item details. Users can scan the barcode or search Mobile Edition to find an item's current contracted price, giving users remote access to approved, contracted item content and pricing.</p>
<p>Shift burden of placing orders to vendors; <b>ensuring adequate control and traceability</b> for cost accounting teams.</p>	 <p>GHX Marketplace gives vendors access to approved, filtered content in Mobile Edition. Vendor reps are limited to adding only approved items for use from their company. The order is then submitted for processing to the appropriate staff who reviews and approves the items prior to processing the requisition.</p>
<p>Direct spend to the <b>preferred, approved supply source.</b></p>	 <p>Mobile Edition uses the same proprietary search algorithms to filter content approved for use based on the user's profile. Users can only request items they are authorized to see in their GHX Marketplace.</p>

- » **Efficiency:** Quickly scan a barcode or search for items needed to order, making it easier to create compliant orders, whether restocking a supply room or submitting consignment item requests in the OR.
